Background

- STCW
 - January 1st 2017 Resolution MSC 396 + MSC 397 into force.
 - Chapter V(Special training requirements for personnel on certain types of ships)
- DMA
 - June 08 2017 Executive order 722 for minimum protection of different categories of persons on board ships.
 - 2019 DTU Aqua Maritime section starts talks with DMA
 - 2020 First courses.



Agrement with DMA

- 2 categories.
- Vessel responsibilities 2 days STCW certified training.
- No vessel responisbilities and less than 3 months sailing per year 1 day basic safety instruction held by DTU Aqua.
- Vessel responsibilities:
- Small boats captains
- Small boats crew
- Additional crew on larger vessels e.g. Stewards on DANA
- No vessel responsibilities:
- Crusieleaders and scientist
- Technicians
- Eksternal charteres
- Students



Basic survival training

- The very core of this section is –
- DO NOT GET WET
- Survival is defined as the ability to stay alive when life is threatened after shipwreck by:
 - fire;
 - explosion;
 - Collision;
 - grounding; or
 - Man overboard ('MOB')



Certificate
